

Young Composers Contest Rules Make Music Day 2022

No purchase or payment of any kind is required to enter or win.

The “Young Composers Contest” (“Contest”) is sponsored by the Make Music Alliance (“Sponsor”). This contest is governed by these official rules (“Official Rules”). By participating in the contest, each applicant agrees to abide by these Official Rules, including all eligibility requirements, and understands that the results of the contest, as determined by Sponsor and its agents, are final in all respects. The contest is subject to all federal, state and local laws and regulations and is void where prohibited by law.

ELIGIBILITY

The Contest is open to applicants between thirteen (13) years of age and twenty-one (21) years of age on the closing date (May 22, 2022 at 11:59pm EST), who have Internet access, and a valid email account. Applicants may not be a current or former employee of, nor related to a current or former employee of Make Music Alliance. Sponsor has the right to verify the eligibility of each applicant. Each applicant must retain copyright of submitted composition. If applicant loses the copyright of a submitted composition, the applicant forfeits consideration in this contest.

ENTRY DETAILS

- Each applicant may submit only one composition for consideration in the program. If more than one composition is submitted, only the first entry will be considered.
- Compositions written by more than one individual are not eligible.
- Compositions must use the text of the poem “A Jelly-Fish” by Marianne Moore. This text is in the public domain. No other text may be used.
- Compositions must be no more than four minutes long.
- Compositions must be original and the sole creation of the applicant. Entries must not be plagiarized or violate copyright laws.
- Entries must not have previously been submitted for publication by applicant nor accepted by another organization with the intent to publish.
- By submitting, applicant consents to a recording of their submission being uploaded to [YouTube.com](https://www.youtube.com) and [Soundcloud.com](https://www.soundcloud.com), and linked to from [makemusicday.org](https://www.makemusicday.org).
- There is no fee to apply.

CONTEST PERIOD

April 6, 2022 - Contest open for submissions

April 23, 2022 - virtual meeting / Q&A with some members of The Swingles for entrants to the contest

May 22, 2022 at 11:59pm EST - Deadline for submissions

June - Judges make their selections and send winning pieces to The Swingles to record

June 21, 2022 - Recording of the winning piece is released for Make Music Day

HOW TO ENTER

Using any notation software, compose a piece for The Swingles. The Swingles range charts and links to samples of their work are included in the entry details at <https://www.makemusicday.org/national-projects/young-composers-contest/>.

Submit the finished score in BOTH PDF & MusicXML format via one of the following Google forms:

Scores should contain composer's name and email address on the first page in the top right corner. (This identifying information will not be seen by the judges.)

WINNER SELECTION

Winners will be judged by a panel of judges. Selection will be based on originality/creative potential, skill at writing for voice, and overall musical effect. Winners may be contacted by the Make Music Alliance for the purpose of marketing content including, but not limited to blog or social media posts. All licensing rights to pieces submitted will remain with the individual. The winning composition will be recorded by The Swingles and released on Make Music Day, June 21st 2022.

ADDITIONAL LIMITATIONS
